1.0 Introductions

2.0 Operational Review:

FR noted we are currently extracting in Phase 3, 1 and 2 have been exhausted, Phase 3 has beencleared of trees and topsoil which are being used as bunding. Ecological work going ahead on Phase 4, we've put in drift fencing which is to compartmentalise the phase to aid in capture the reptiles, a fair few adders have been caught so far. Hoping to start clearing Phase 4 of trees after bird nesting season (Oct/Nov), Phase 2 ripping to be discussed between Richard and Frank outside of meeting. Pond that was in phase 5 is being relocated, Richard noted there were a few newts in there at one point but was bone dry when filling commenced, FR noted that it is now complete. Fresh water ponds that we have, the driest spring we have had in 100 years has decreased the water we can use so not sure how long we can keep producing before the winter rains come in. Plant production has ramped up with the good weather and we can get the material through the plant better, averaging around 14000-18000 tonnes processed a month and around 12000 tonnes a month sold, we would like to be selling more but the industry is slow at the moment, several building projects for housing have halted around Berkshire.

Estates: Richard wants to plant the trees in the winter in phase 2, will take 12-15 thousand trees so we're hoping for a wet spring and summer next year to assist with the trees growing, if we had planted these in the December gone 100% of those trees would have died due to the weather this year.

No noise issues, no dust issues and no issues with HGVs, all really pleased. FR noted the state of Welshmans Road and the potholes/damage, FR did mention that if the community does have any issues they are welcome to come in during the week to go through them.


